Amazon Distribution Facility Scheduled to Open September 21, 2016

Amazon plans to open its new fulfillment center located on Innovation Way in the South-coast Life Science and Technology Park on September 21, 2016.

As the construction of the facility nears completion, the 500 employment positions will be open to applicants beginning July 22, 2016. The starting pay for most positions will be \$12.75 to \$14.75 per hour and the workweek consists of four 10 hour days.

Beginning July 22, 2016 the Amazon jobs will be posted online and applicants will be required to fill out an online assessment. The assessment takes approximately 45 minutes to complete and will determine if the applicant will move onto the next step in the hiring process.

Anyone interested in a job at Amazon must have a high school diploma or its equivalent and pass a drug test. Internet access and a personal email address are needed to complete the application process.

Amazon has been working closely with the Fall River Career Center (FRCC), so all inquiries should be directed to the FRCC at 508-730-5000.

Strong Year for the FROED Loan Program

The Fall River Office of Economic Development (FROED) closed loans totaling \$2,231,000 in fiscal year 2016. The \$2,231,000 represents 14 loans to businesses in Fall River and Freetown. In turn the loan clients, collectively, will create 31 new fulltime jobs and 18 new part-time jobs.



FROED Hiring Economic Development Administrative Assistant

The Fall River Office of Economic Development is seeking to hire an Economic Development Financial Administrative Assistant to work with the Executive Vice President and the Director of Administration in a transitionary role to understand and manage the financial operations of the office. Amongst other things, the candidate will need to possess a college degree in accounting along with a demonstrated track record of financial management of private and nonprofit businesses and corporations. The candidate will also need to demonstrate experience in payroll preparation, state and federal tax filings, preparation of CDBG, EDA, SBA and bank financial reports on a monthly, quarterly, semiannual and annual basis, reconciliation of all revolving loan fund accounts receivables, development of in-house financials, annual budget preparation,

health care insurance policies, loan servicing, assist in independent audit preparation, forward annual audit findings to identified funding sources. Ultimately this position will be merged into the Director of Administration position.

Fall River's Finest: Malcolm "Mac" Aldrich

Malcolm Aldrich was born in Fall River in 1900 to Stanley and Jane Pratt Aldrich, he had two brothers. Aldrich attended local Fall River schools including BMC Durfee High School where he was the captain of both the baseball and football teams.

Aldrich also attended Pomfret Preparatory School and Yale University where he was an All-American football and baseball player and served as captain of both sports.

Upon graduating from Yale in 1922, Aldrich joined the staff of philanthropist Edward S. Harkness. Upon Harkness' death in 1940, Aldrich became President of the Commonwealth Fund, a charitable foundation dedicated primarily to medical research and education. Aldrich was chair of the board until his retirement in 1953.

He was well known by profit and not-for-profit groups alike and served on the board of directors of The Museum of Natural History, The Metropolitan Museum of Art, The Columbia-Presbyterian Medical Center, The New York Trust Company, the American Electric Power Co. and the New York Central Railroad, among others.

Aldrich achieved rank of captain in the Naval Reserves after serving as special assistant to the Assistant Secretary of the Navy for Air during WWII. He received the first Durfee Distinguished Alumni Award in 1962 and in 1979 the football field at the high school was dedicated in his honor.

Aldrich married Ella Buffington and they had three children and six grandsons. Aldrich died in 1986.
